



School Bus Rules and Expectations 2024-2025

STUDENTS SHALL:

- Arrive at the pickup point 5 minutes before the bus is scheduled to leave
- Keep windows open when possible
- Use appropriate language (no use of profanity will be allowed)
- Be nice and respectful to others (no physical or facial gestures of intimidation or hateful comments will be allowed)
- Use proper tone of voice (no yelling loudly at others or at moving vehicles out the window)
- Remain seated at all times (no switching seats, no pushing or inappropriate touching of others)
- Sit facing the front and no obstructing the aisles
- Sit in a particular seat if instructed by bus driver
- Wait to cross street when directed by bus driver (no running across the street and behind the bus)
- Use electronic devices appropriately (must wear one headphone or ear piece, no music with inappropriate language and no viewing of inappropriate websites or images)
- At the request of the bus driver, students must reveal their first and last name (no refusing or acting defiant)
- Follow all emergency protocols as directed by the bus driver (no use of emergency exits without driver approval and no running to the bus entrance door without driver approval)
- Must wait at all the designated bus stops
- Be picked up and released at the same bus stop. Preschool- 3rd grades are required to be delivered to, and met, at stops by a parent or guardian. Parents must have approval from superintendent for exceptions to this rule.
- Do not bring live animals while riding the bus
- Do not bring weapons of ANY KIND on the bus
- Do not take pictures of other students
- Not possess, use, sell or be under the influence of any controlled substance, alcoholic beverage, intoxicant, or tobacco
- Not bring pressurized containers such as paint spray cans
- Not bring glass containers or items that are breakable

Los Molinos Unified School District Home to School transportation is a privilege provided to students. We have rules that all students must follow while under the supervision of the school bus driver. If students are unable to follow the rules of the safe school bus riding, students may be denied the privilege of riding the school bus. This contract must be signed and followed in order to continue riding the school bus. Any violation after this contract is signed will be progressive and administered by the site principal.

_____ Initial. I understand that my school day begins at my designated school bus stop and my school day ends after school at my designated bus stop. I agree to follow the direction of the school bus driver in a courteous and respectful manner. I agree to treat other students on the school bus or at my bus stop in a courteous and respectful manner. I agree to treat the property of the school bus and the school bus stop in a respectful manner.

If I violate any school bus rules I am aware that I will be subject to school discipline as well as losing privileges of riding a school bus.

Education Code 44807:
